### **Responsibilities:**

- Supervise players and establish positive relationships across the coach/instructor team
- Liaison with parents and manage parent communications
- Address and resolve parent issues with VP of Football as needed
- Maintain all squad records (attendance, behavior, and injuries)
- Attend pre-season coaches meetings
- Attend pre-season SFC rule meetings
- Attend practice all/most of the time
- Attend games
- Actively participate in the coaching team communications across all squads, sharing ideas and solutions with coordinators and other coaches

### **Coaches Code of Ethics:**

- I will encourage and demonstrate by example the importance of good sportsmanship and positive support for all players, coaches and officials at all practices and games
- I will place the emotional and physical well-being of my players ahead of my personal desires to win.
- I will do my best to insist on a safe playing situation for my players.
- I will insist on teaching my players that rules are important and must be followed to win a team competition.
- I will do my best to organize practices that are fun and challenging for all my players.
- I understand that verbal and physical abuse is not to be tolerated against anyone in the association, including profanity and foul language.
- I will use coaching techniques appropriate for all of the skills that I teach.
- I will follow all rules set forth by the Board.

**Coaches must be dependable. The coach must be at each practice, game, and team function prior to the team and stay until each child has been picked up. Head coaches must also attend the monthly coaches meetings.**

**Coaches must represent the league in fundraisers. Our league is a non-profit organization run solely by volunteers.**

**A Head Coach must be willing to help when help is needed. Clean-up after games, announcing, running the clock, etc. It is easy to overlook what it takes to run this League and Head Coaches must be willing to step in when help is needed.**
