

FOLSOM JR. BULLDOGS YOUTH FOOTBALL/CHEER PARENT/PARTICIPANT CONTRACT

FINANCIAL RESPONSIBILITY AND PARENT/PARTICIPANT CONSENT

1- The parent/guardian of the below named child, do hereby give my/our approval for participation in Folsom Youth Football/Cheer (FYFC) activities for the current season. I/We assume all risks and hazards to this participation for any claims arising out of injury to the above named child, including, but not limited to, transportation to and from such activities. I/We hereby waive, release, absolve, indemnify and agree to hold harmless, FYFC, the league (SFC), Folsom Park & Recreation, organizers, coaches, board members, participants, person providing transportation and any organization this youth football program may be affiliated with.

2- In executing the foregoing release. I/We acknowledge that I/We understand that our personal medical/dental insurance will remain the primary carrier, and that insurance offered through this program is secondary in nature and is subject to an annual deductible by the carrier. It is understood that any claim for injury arising out of my/our child's participation must be reported to the designated association official within 30 days of the date of injury. It is also understood that the proof of loss must be completed in full and filed within 60 days of receipt by FYFC. All moneys I/We have paid to the team do not constitute payment of insurance coverage. I/We do indemnify FYFC, the association and the insurance carries should there be statement (s) by anyone that is in contradiction. I/We have read and understand the terms of this contract and any disclosure information required.

3- I/We understand that if player/cheerleader has not had their physical examination after April 16th of the current year they will not be allowed to participate in any FYFC activities. **I/We hereby grant to a qualified physician permission to administer medical treatment, as said physician deems necessary under emergency circumstances.**

4- I/We understand that FYFC has established a **No Tolerance Policy for Improper Adult Behavior**. I/We have read the FYFC Adult Code of Ethics and agree to abide by this policy.

5- I/We understand that FYFC has established a policy whereas each member must volunteer 10 hours per child in the program. I/We understand that if we fail to show up for our scheduled volunteer time, our child will be benched the following game. By signing this document, I agree to abide by this contract.

6- FYFC players and cheerleaders are precluded from participating in any other tackle football or competitive cheerleading program concurrent with FYFC football season. This rule does not apply to intra-scholastic physical education activities.

7- My child's name/picture may be released for the Jr. Bulldog directory, web site or press releases.

8- I/We have read and understand fully the provisions of this consent/release authorization, and I/We have voluntarily signed it.

I/We have read the 2012 Participation Handbook, understand and agree, as parents/guardian of the below named child to abide by the role of the parent and player's code of conduct and assume the absolute financial obligation for my/our child to participate in this youth program.
